## Meet the new Board of Trustees of the Eskom Pension and Provident Fund

The EPPF is governed by a Board of Trustees, which provides strategic guidance on the management of the EPPF. Board members are elected every four years and a new Board of Trustees (the Board) was appointed for the four year term that began on 1 June 2016. Half of the Board (seven Trustees) is elected by pensioners and members and the other half was appointed by the employer, Eskom holdings SOC Ltd.

The Board is entrusted with directing, controlling and overseeing the operations of the EPPF. In order to fulfil that mandate the Board must:

- act in the best interest of the members and pensioners of the EPPF;
- ensure that the EPPF is managed in a transparent and fair manner in accordance with the relevant legislation and the Rules of the EPPF;
- ensure that proper registers, books and records of the EPPF's procedures are kept;
- ensure that enough and correct information is communicated to members of the EPPF about their rights, benefits and duties in terms of the Rules of the EPPF;



- take reasonable steps to ensure that contributions are paid on time to the EPPF; and
- obtain expert advice on matters where the Board requires additional expertise.

The Board delegates the day-to-day management of the EPPF to the Executive Management, which is led by the Chief Executive, who is also the Principal Officer of the EPPF.

## Garnishee Orders – Tax on your pension

The Tax Administration Act empowers the Commissioner for the South African Revenue Service (SARS) to appoint a third party to withhold and pay over to SARS, any amounts due by a taxpayer in terms of the relevant Tax Act.

This is called the Third Party Appointment (AA88) process and the third party may be an employer of the taxpayer or any other person who has the management, custody or control of any income, monies or property of the taxpayer

EPPF is appointed as a third party to withhold and pay over to SARS any tax owed by EPPF pensioners.

To ensure that your tax affairs are always in order, follow the following basic guidelines:

- If you already have an AA88 deduction on your pension, you need to visit your nearest SARS branch to resolve your tax matters. Always verify whether the garnishee (AA88) has your correct tax reference number.
- If you earn two incomes regardless of the amount per annum - you should submit your returns to avoid a penalty for non-submission of returns.
- If you are a newly retired pensioner, you are still required to submit your returns.
- If you are a widow/widower pensioner who is also working, you should also consider requesting for a voluntary tax deduction in order to reduce your tax liability at the end of the tax year, as you may always owe SARS due to the primary rebate granted.

## Skuldbeslagorders – belasting op jou pensioen

Die Wet op Belastingadministrasie stel die Kommissaris vir die Suid-Afrikaanse Inkomstediens (SARS) in staat om 'n derde party aan te stel om enige bedrae verskuldig deur 'n belastingbetaler kragtens die betrokke Belastingwet terug te hou en aan SARS te betaal.

Dit staan bekend as die Derdeparty-aanstellingsproses (AA88), en die derde party mag 'n werkgewer van die belastingbetaler wees of enige ander persoon wat die inkomste, gelde of eiendom van die belastingbetaler bestuur, bewaar of beheer.

EPPF is aangestel as 'n derde party om enige uitstaande belasting deur EPPF-pensioenarisse terug te hou en aan SARS oor te betaal.

Om te verseker dat jou belastingsake altyd in orde is, moet jy die volgende basiese riglyne volg:

- Indien daar reeds 'n AA88-aftrekking op jou pensioen is, moet jy na jou naaste SARS-tak gaan om jou belastingsake uit te sorteer. Maak altyd seker dat die skuldbeslagorder (AA88) in alle gevalle jou regte belastingverwyingsnommer bevat.
- Indien jy twee inkomstes verdien ongeag wat die bedrag per annum is –moet jy jou opgawes indien om dit te vermy dat jy 'n boete moet betaal omdat jy versuim het om jou belastingopgawe in te dien.
- Indien jy onlangs afgetree het en nou 'n pensioenaris is, word daar steeds van jou verwag om jou opgawes in te dien.
- Indien jy 'n weduwee/wewenaarpensioenaris is wat ook werk, moet jy dit ook oorweeg om 'n vrywillige belastingaftrekking te vra sodat jy jou belastingaanspreeklikheid aan die einde van die belastingjaar kan verlaag, aangesien jy dalk iets aan SARS verskuldig is vanweë die primêre korting wat toegestaan is.

- Uma uhola imiholo emibili ngisho noma ngabe yimalini ngonyaka - kumele uhambise izimbuyiselo zakho ukuze ugweme isijeziso ngokungazihambisi izimbuyiselo.
- Uma uwumuntu ohola impesheni osanda kuthatha umhlalaphansi, usadingeka ukuthi uhambise izimbuy iselo zakho.
- Uma uwumfelokazi/umfelwa ohola impesheni futhi osebenzayo, kumele udlinze ngodaba lokucela ukubanjelwa intela ngokuzinikela ukuze unciphise isikweletu sakho sentela ekupheleni konyaka wentela, ngoba kungenzeka uhlale ukweleta i-SARS ngenxa yanoma eyiphi imali oyikhokhelwe eyisisekelo.

## Taelo ya ho hula tjhelete moputsong – Lekgetho tjheleteng ya hao ya penshene

Molao wa Tsamaiso ya Lekgetho o fa Khomishenara ya Ditshebeletso Tsa Lekghetho Tsa Afrika Borwa (Commissioner for the South African Revenue Service [SARS]) matla a ho kgetha motho wa boraro hore a tshware tjhelete le ho lefa SARS tjhelete eo, ebang molefi wa lekgetho o lokela ho e lefa ho latela Molao wa Lekgetho o amehang.

Sena se bitswa ho Kgetha Motho wa Boraro (Third Party Appointment [AA88]) mme motho eo wa boraro e ka ba mohiri wa molefi wa lekgetho kapa motho ofe kapa ofe ya laolang, ya nang le matla kapa ya laolang moputso, ditjhelete kapa thepa ya molefi wa lekgetho.


EPPF o kgethwa e le motho wa boraro hore a tshware mme a lefe SARS tjhelete ya lekghetho eo ebang batho ba EPPF ba amohelang penshene baa e kolota.

E le ho etsa bonnete ba hore ditaba tsa hao tsa lekgetho di maemong a nepahetseng, latela mehato e latelang ya mantlha:

- Haeba ho se ho na le tjhelete ya AA88 e hutsweng tjheleteng ya hao ya penshene, o lokela ho itlhahisa lekaleng la SARS le haufi e le hore o lokise ditaba tsa hao tsa lekgetho. Kamehla etsa bonnete ba hore tjhelete e hulwang moputsong wa hao (AA88) e na le nomoro e nepahetseng ya lekgetho.
- Haeba o amohela meputso e mmedi, ho sa tsotellehe hore na e etsa tjhelete e kae ka selemo, o lokela ho kgutlisa dipampiri tsa lekgetho e le ho qoba kotlo eo o ka e fumanang ya ho se kgutlise dipampiri tsa lekgetho.
